Established in 2006, company develops and publishes games and entertainment applications for mobile devices. Recognising the surge in demand for mobile gaming, they aim to expand into a fully fledged online games publisher, focussing on high quality downloadable games for the iPhone, Google's Android, the Nintendo Dsi and Sony PSP. A LINC member and the Scottish SEED Fund provided the first external funding of £200K in Autumn 2007. They will also be contributing to the current round and would welcome additional investors to complete £300K package.
